- **2.4.** It was moved by George and seconded by Andrew to accept the consent agenda as circulated.

3. Report from Member of Parliament for Ottawa South: The Honourable David McGuinty

- **3.1.** MP David McGuinty provided an oral report that addressed a perception he developed in the course of campaigning of anxiety and concern in the riding, particularly with regard to affordable housing, climate change and healthcare wait times.
 - 3.1.1. MP McGuinty announced plans to convene a meeting of the presidents of the community associations from the riding to discuss common issues
 - 3.1.2. While a barrier to addressing the affordable housing issue, as well as other projects, involves the provincial government's blocking of 11 million dollars in funds earmarked for Ontario, new support has recently been provided to local police services, some of which focused on crown prosecutorial services.
- **3.2.** MP McGuinty responded to questions from meeting attendees and RPCA Directors. The following issues were addressed:
 - 3.2.1. Support and championing are required for the preservation of McCarthy Woods and Mooney's Bay. MP McGuinty noted the appointment of a new chair to NCC, as well as permanent membership on the NCC for the mayors of Ottawa and Gatineau. The MP intends to work closely with Councillor Brockington on the Mooney's Bay Pavilion redesign. The hope is for an eco-efficient showpiece that can be used year-round for multiple purposes.
 - 3.2.2. The vision for addressing affordable housing involves a focus on vulnerable populations, including seniors, disabled populations, veterans and those experiencing Post-Traumatic Stress Disorder, and displaced youth. The federal government will work with local and provincial governments to decide on development priorities.

- 3.2.3. The MP will consider what an explicit statement against development occurring in McCarthy Woods and Linton Park could look like.
- 3.2.4. In terms of transportation, advocacy will not include efforts for roads because more roads mean more cars. The government is trying to have a macro look at the region and build transportation infrastructure for the next hundred years.

4. Receipt of Additional Officer and Committee Reports

4.1. No additional Officer and Committee Reports were submitted

5. Assessment and Follow-Up to the Annual General Meeting (AGM)

- **5.1.** A summary of the RPCA AGM was provided. George Brown has volunteered to lead efforts on implementing a change to the RPCA bylaws regarding the association's name change to the Riverside Park Community Association from its former name, the Riverside Park Community and Recreation Association.
- **5.2.** It was noted that attendees remained engaged and in attendance for the entire three-hour meeting and that membership has increased since the AGM.

6. River Ward Councillor's Report: Riley Brockington

- **6.1.** The focus of the Councillor's oral report was on budget allocations and traffic calming. The Councillor also provided a written report on traffic calming (see Appendix B).
 - 6.1.1. Traffic calming is a tool meant to improve safety on our roads for all users, not just motorists, but also vulnerable users such as pedestrians and cyclists.
 - 6.1.2. There is currently a \$50,000 annual budget (up from \$40,000 last year) for traffic calming for each ward, which can be allocated at the discretion of the Councillor. A greater array of permanent options is now available, rather than seasonal ones only.
 - 6.1.3. The perceived need for traffic calming has not arisen as a result of accident statistics, but is rather the result of concerns voiced to the Councillor's office by community members. However, statistics about volume can be made available.
 - 6.1.4. The Councillor needs to provide a tentative list of traffic calming measures to city staff by Nov 30th. The current proposal for 2020 focuses on the following priority areas:
 - 6.1.4.1. Flannery Drive and Springland Drive
 - 6.1.4.2. Provost Drive
 - 6.1.4.3. Fielding and Southmore Drive West intersection
 - 6.1.4.4. Revelstoke community near Geoff Wightman Park
 - 6.1.4.5. Brookfield Road, eastbound
 - 6.1.4.6. Replacement of all speed display boards, of older vintage that are non-solar powered.
 - 6.1.5. Community members in attendance raised concerns about the following issues:
 - 6.1.5.1. High speeds on Flannery Drive

- 6.1.5.1.1. Speed tables or bumps on Flannery Drive have not been proposed because of high costs, which would be approximately \$10,000 per speedbump. Springland has been prioritized because of heavier volume.
- 6.1.5.2. High speed cycling through the cow tunnel at Springland and Flannery
 - 6.1.5.2.1. The Community has taken it upon itself to paint "slow/lent" on the road, but additional measures will be taken to slow cyclists.
- 6.1.5.3. Possible traffic delays as a result of construction traffic using Canoe Bay entrances from Riverside Drive
 - 6.1.5.3.1. The Councillor made note of this and will investigate.
- 6.1.6. The Councillor also noted that a million dollars was allocated in the city's budget to pave Riverside Drive from Hunt Club to Walkley.

7. New Business

- 7.1. West Walkley Road Traffic Calming Pilot Project
 - 7.1.1. The Land Use, Development and Transportation Committee is supportive of a traffic calming pilot to test measures to be introduced as part of the planned Airport Parkway Expansion on West Walkley Road between the Airport Parkway and McCarthy Road. Data collection will be important and a duration of two weeks seems insufficient to affect travel patterns so they can be sufficiently measured.
 - 7.1.2. The pilot could seek to evaluate the potential to reduce speeds, shorten queue and waiting times for turning on/off of Walkley Rd, and reduce cut-through traffic on side streets.
 - 7.1.3. During the pilot, no modifications to the traffic lights will be made, nor will speedbumps be added because Walkley is considered an arterial road.
 - 7.1.4. The high potential for the pilot to create chaotic and dangerous traffic situations was raised, especially with lane reductions. There was a divergence of opinion amongst attendees about whether a permanent lane reduction on Walkley was feasible, as recommended by the City as part of the Airport Parkway Expansion Project
 - 7.1.5. Councillor Brockington was asked to take into consideration the discussion and comments provided by the RPCA in his further development of the proposed pilot project and to consult further with the RPCA about it.

7.2. Canoe Bay Park

7.2.1. The developer has provided financing for the park, but ownership of the park will remain with the city. Resident feedback was taken into consideration in re-planning the park layout and the inclusion of additional natural elements. Feedback on the revised design will be collected until November 8th.

- **7.4.** With respect to the regulation of short-term rental accommodations, the City Staff's report is consistent with Community Association's own report on the topic. Terry Wood volunteered to draft letter of support to the City's plans.
- **7.5.** Andrew Wintonic provided an update to the board about the potential need for a new rink liner for the ice rink at Pauline Vanier park. The cost estimate for a new liner is approximately \$900 + HST.
 - 7.5.1. A motion was made by George Brown and seconded by Mark Staz to allocate funds for the purchase a new liner up to the amount of \$900 + HST.

- 7.5.2. The Councillor will discuss re-grading terrain with the City to avoid water loss and need for future liners.
- **7.6.** A motion was made by Nicole Christy and seconded by Andrew Wintonic to postpone the Board Retreat and Action Plan Review to a future meeting date.





- The RPCA has been promoting all of these companies to residents as new options.





- Councillor Menard is circulating a petition to protect public use of Landsdowne Park.







Regulation of Short-Term Rental Accommodation

- Consultant's report issued September 23, summarizing results of public consultations over the summer, with 13 recommendations which, if adopted, would establish a comprehensive regulatory framework. Consultants included many RPCA proposals.
- City Staff will issue their own report by November 5, which will be considered by a special Community and Protective Services Committee meeting on November 15 and by City Council on November 27.
- Establishment of an effective regulatory framework would address unregulated commercial operations, including "ghost hotels", and could return over 1,000 rental units to the longer-term rental market.

Traffic Calming in Riverside Park - 2020

What is Traffic Calming

Traffic calming refers to measures and street design elements aimed at improving safety for all street users – particularly for those walking and cycling. Traffic calming is also used as a tool to improve the public realm, helping meet broader policy objectives related to encouraging sustainable modes of travel, and helping create a better sense of *place*.

It aims to help achieve these objectives by reducing impacts of motorized vehicles on neighbourhoods and supporting safer street environments.

Traffic Calming Toolbox

Part 2 of the Traffic Calming Design Guidelines supplements the traffic calming measures outlined in the Transportation Association of Canada's (TAC) Canadian Guide to Traffic Calming, providing highlights and considerations for the implementation of a variety of traffic calming measures in Ottawa.

The toolbox includes the following measures:

Communication and Enforcement Measures

• information signage, speed display devices and educational campaigns

Minor Adjustment Measures

• pavement markings (on-road messaging and full-lane transverse bars), street parking and vertical centerline treatments

Engineering and Traffic Management Measures

- vertical deflection
 - raised crossings
 - raised intersections
 - speed cushions
 - speed humps
 - speed tables
- horizontal deflection
 - chicanes
 - corner tightening / curb radius reductions
 - mini-roundabouts
 - bulb-outs
 - lane narrowings
 - raised median islands
 - road diets
- surface treatments
 - textured crossings

- textured surfaces
- transverse rumble strips
- traffic management
 - vehicular directional closures
 - vehicle diverters
 - on-street plazas / vehicle access closures
 - intersection channelizations
 - raised medians through intersections
 - right-in / right-out islands
- urban design
 - streetscaping
 - gateways

Emerging Measures

• speed kidneys, creative pavement markings, shared spaces, woonerven ("living streets") and automated speed enforcement

Designs should also allow for effective street maintenance, vehicle traffic and transit operations, and emergency response – particularly on citywide thoroughfares, ie arterial streets. Where local context and citywide objectives do not fully align, significant care should be taken through the design process with respect to more abrupt traffic calming measures such as speed humps speed tables, and speed cushions. On one hand, these measures can be highly effective within an overall traffic calming plan, helping achieve both localized and citywide goals (e.g. support safer routes to a specific school or schools across the city more generally), but they can also potentially have negative effects for various operational activities (e.g. emergency response occurring on a particular street). As such, it is recommended proponents avoid use of speed humps, speed tables, and / or speed cushions on arterial and major collector roads. On arterial and major collector roads that meet the local context criteria described above, proponents should avoid the use of these more abrupt traffic calming measures until all other methods have been explored.

River Ward Traffic Calming Budget

City Council has approved a traffic calming budget of \$50,000 per year for each ward.

- Permanent Speed Humps / Tables
- Median Narrowing Islands / Pedestrian Refuge Islands

Road Safety Issues in Riverside Park and Options to Explore

Most concerns received in my office are for the speed of traffic on Riverside Drive and Walkley Road. A pilot project for Walkley Road is in development and will be shared at a tonight's meeting.

Riverside Drive currently has two mounted speed display boards, one southbound, and one northbound, in the Revelstoke vicinity.

Here are the other streets where issues remain a challenge

1. Flannery Drive and Springland Drive

Local residents raise concerns about both volume and speed of traffic, with a moderate level of vehicles exiting the southbound Airport Parkway at Brookfield Road.

Current Mitigation

Flannery has painted messaging on the street, while Springland has the same, in addition to yellow flex sticks and a formal crosswalk just north of Holy Cross Catholic School.

Proposal 2020:

- Construct a speed table/crosswalk on Springland Drive connecting Springland (between 790 and 840 Springland) with the pathway extending north towards Paget Park and Brookfield HS.
- Construct an elevated speed table on the existing crosswalk on Springland just north of Holy Cross Catholic School.
- Install yellow flex sticks near Flannery Green Park (where feasible)

2. Provost Drive

The volume and speed of traffic, particularly in the morning rush hour, presents safety issues for pedestrians, who are either walking to Ecole Geroge Etienne Cartier or their local bus stop.

Current Mitigation: Painted messaging. I have also been successful in getting this street added to the sidewalk construction list.

Proposal 2020: Install yellow flex sticks, remove parking on a small section near McCarthy which is currently creating sightline issues.

3. Fielding / Southmore Drive West intersection

Local residents have requested the installation of a stop sign due to the flow and speed of traffic. The volume of traffic that travels through this intersection does not warrant a new stop sign.

Current Mitigation: None.

Proposal 2020:

- Paint messaging on Fielding Drive
- Consider additional yellow flex sticks, two more on Fielding on either side of Southmore
- Paint cautionary message for cyclists/pedestrians who are exiting the cow tunnel pathway that empties on to Fielding Drive

4. Revelstoke community, near Geoff Wightman Park

A resident has requested the installation of a speed display board. This request is under consideration and if the budget permits, will be added. The low volume of vehicles in this community, does not rank this request at the top of the list.

5. Brookfield Road, eastbound

The speed of vehicles on Brookfield Road has been observed to be an issue, particularly in the vicinity of Brookfield HS.

Proposal 2020: Install a new speed display board on Brookfield Road, eastbound.

6. All speed display boards, of older vintage, non-solar powered, will be replaced.
