### **Riverside Mall Owners Encouraged** to Create Mixed-Use Community Hub

- In early November 2019, the Riverside Mall was sold to Brigil Construction, a local developer based in Gatineau, QC.
- At a Dec. 5 meeting hosted by Councillor Brockington, the RPCA and representatives from two abutting condo boards met with Brigil to learn more about its plans for the site.
- The RPCA welcomed the new developers and encouraged the company to listen to residents and work closely with the community association to support modern mixed-use development with much needed commercial amenities and community services.
- In the late winter, 2020, Brigil will share their preliminary vision for the site.
- Councillor Brockington has committed to hosting Open House and consultation meetings.






