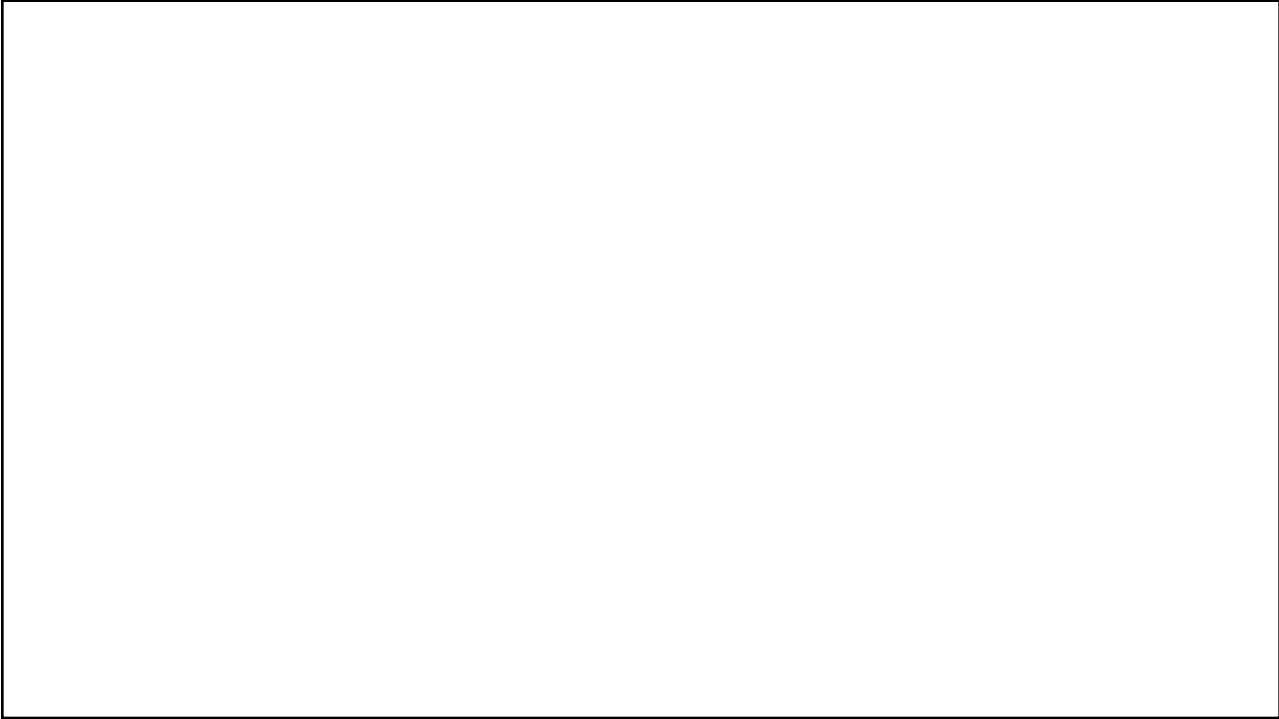

Hog's Back Construction Delay

- Just as residents' frustrations mount about the inconvenience of the Hog's Back Road closures, the National Capital Commission recently announced a delayed completion of the Hog's Back swing bridge repair.
- Citing challenges during the procurement and construction process, the NCC forecasted that the Hog's Back Swing Bridge will be closed an additional three months, until August 28th, 2020.

Ottawa Ward Boundary Review 2020

- The city announced the first round of public consultation for the Ottawa Ward Boundary Review 2020.
- The first round (March 4 – April 3, 2020) is aimed at receiving input from residents, key stakeholders and Members of Council on the City's current ward boundaries.
- It will result in an Information Report setting out new ward boundary options, which will be considered by the Finance and Economic Development Committee and Council in Q2 2020.
- Nine public consultation sessions have been scheduled at facilities across the City, including:
 - Monday, March 30, 2020, from 7:30 p.m. – 9:30 p.m. at the Jim Durrell Recreation Centre.
 - A dedicated website, ottawa.ca/wardboundary, will launch on March 4, 2020.
 - A second round of public consultation will occur following Council's consideration of the Information Report in Q2 2020.

R1 to R4 Infill Zoning Review for Residential Communities Within the Greenbelt (1)

- Follows-up a 2018 study of new developments, notably infill of new lots and dwellings, and additions to existing homes.
- Planning changes would apply to all residential neighbourhoods within the Greenbelt zoned R1 to R4 – **includes Riverside Park**.
- Most neighbourhoods are dealing with new developments and Council policy is to ensure that these fit into the “developed context” that surrounds them.
- Allowing additional **on-site** (e.g. front yard) **parking** for existing properties and for new developments **is a major focus of attention** (hence the proposed “Landscape First” strategy – see next slide);

R1 to R4 Infill Zoning Review for Residential Communities Within the Greenbelt (2)

- Two “overarching zoning strategies” are being considered that would:
 1. **Put “Landscape First”**: Before a driveway, walkway or a building projection is permitted, part of the front and side yards must consist solely of “soft landscaped” area in order to ensure sufficient on-site space for stormwater and snow storage and for a tree; and,
 2. **Apply most rules for mature neighbourhoods** (“Infill I” area; inner-city communities) **to all other residential neighbourhoods within the Greenbelt** zoned R1 to R4 (“Infill II” area; includes Riverside Park).
- City and Federation of Citizens’ Associations (FCA) are co-hosting a **Public Information Session on March 5**; RPCA will participate.
