CONSTRUCTION NOTICE

April 2020

Dear Resident,

COVID-19 is an unprecedented situation and the City of Ottawa is committed to protecting people and the community. The Province of Ontario has deemed construction an essential service and therefore, construction is continuing. The City is working closely with the industry and complying with restrictions and recommendations provided by health officials at municipal, provincial and federal levels and the Ministry of Labour, Training and Skills Development.

As part of the City of Ottawa's annual infrastructure maintenance cycle, road resurfacing will occur to improve roadways and the citywide transportation network. This road resurfacing project in your neighborhood will begin in late April 2020 and will continue until mid-September 2020.

Who: The Contractor, R.W. Tomlinson Limited, will be performing the construction work for

the City of Ottawa.

Why: The City of Ottawa will be resurfacing Riverside Drive as preventative maintenance

aimed at extending the City's roadway network lifecycle.

What: Work will involve milling of the existing asphalt surface, placement of granular road base,

adjustment of manhole and catch basin frame and covers, extensive concrete curb and

sidewalk repairs, and roadway resurfacing.

When: This work is tentatively planned to begin in late April - weather permitting. Completion

is anticipated by mid-September 2020.

Where: Work will occur on Riverside Drive from Hunt Club Road to Walkley Road.

Riverside Drive will be resurfaced during the day and evening and will involve daytime non-peak lane interruptions and major evening and night lane interruptions. To mitigate construction impacts on Riverside Drive, most of the paving work will be during the weeknights and weekends between the hours of 7 pm and 6 am, although activities during non-peak daytime hours are permitted. Weekend work is anticipated on Riverside Drive and traffic interruptions may also be experienced due to flagging operations.

Similar notice will be issued two weeks prior to the start of any night work.

Accessibility

Accessibility is an important consideration for the City of Ottawa. The City makes every effort to provide access through and around construction sites. If you require special accommodation, please contact the On-Site Inspector or the Contractor's Representative.
